RESERVATION ASSIGNMENT, RULES AND SHOW STANDARDS

In order for all to have a safe and enjoyable show, please read and observe the following rules. Infractions of these rules will be grounds for removal from the show **without refund**.

1. Set-up Friday from 8:30 a.m. until 6:30 p.m. and Saturday from 7:30 a.m. until 9:00 a.m. Tables not claimed by 9:00 a.m. on Saturday will be forfeited and resold.

2. Registration for the same space for the next show can be made on Friday from 10:00 a.m. until 6:00 p.m. and Saturday from 7:30 a.m. until 4:00 p.m. Spaces not renewed by 4:00 p.m. Saturday will be available on a first come/first serve basis Sunday morning. New vendors, and those wishing to change spaces, may register Sunday from 8:00 a.m. until 3:00 p.m. **NO REFUNDS**. Rollovers are permitted with 21 days notice prior to show date. Rollovers are not permitted for two consecutive shows. No rollovers or refunds for inclement weather.

Vendor space is not transferrable without approval of the Dallas Arms.

3. Dallas Arms Collectors Association, Inc. reserves the right to adjust or make changes to space assignments, up to and including the date of move-in, to ensure an even flow of traffic or to maintain the theme of the show.

4. Vendors will receive 2 badges for their first space and 1 for each additional space to a maximum of 8 badges.

5. Prior to setting up your space(s), please confirm that you are setting up on the correct space. All spaces were marked at show set-up.

6. Tables are not to be moved to claim more space or adjusted to establish additional walkways between tables without approval of the show chairman. Passage aisles and table location are established in accordance with fire code and will be enforced. Display cases and boards used to enlarge table top area may not extend into established aisles. Sufficient space must be left behind tables to allow your neighbors to pass.

7. Vendors shall maintain their trade space(s) at the show as rented until 4:00 p.m. on the last day of the show and, should they choose to vacate the show early, they are subject to non-renewal of any and all future trade spaces and forfeiture of any related funds.

8. **Think Safety. NO LOADED WEAPONS!** Law enforcement officers, *with proper ID being displayed*, are the only exception. Never attempt to load any firearm, clip or magazine on the premises for any reason. Check each firearm as you unpack it and every time you handle it during the show. If you sell a firearm to a customer, it must be secured with a cable tie, even if it is boxed or cased. Every gun must be rendered safe and unfireable through the use of a plastic cable tie or other lockable mechanical device (connected and locked). Cable ties are available from any member of the Dallas Arms Safety Committee or at the front desk for a minimal charge. Vendors who examine a firearm from a walk-in customer are required to retie the firearm upon its return to the customer.

10. Vendors are required to supervise all children accompanying them and are responsible for their conduct.

11. No carts or dollies are allowed to pass through any glass doors.

12. Dallas Arms reserves the right to demand the removal of any item deemed to be dangerous, illegal, inappropriate, objectionable, or in violation of the local, state or national law or Dallas Arms' show rules. Failure to abide by show rules, objectionable behavior or failure to cooperate with Dallas Arms or Market Hall officials will be grounds for your immediate removal from the show **without refund**.

13. All Vendors are required to read, be familiar with and comply with all published Dallas Arms Rules and Show Standards as listed herein.



SHOW STANDARDS

Each and every space must comply will all applicable laws. All decisions of the Dallas Arms' Show Chairman, Dallas Arms' Officers and/or Board of Directors to the acceptability of all items offered for sale or display will be final.

1. Dallas Arms Collectors Association, Inc. assumes no liability for loss of property, injuries or business interruption. DALLAS ARMS COLLECTORS ASSOCIATION, INC. IS NOT RESPONSIBLE FOR ACTUAL DAMAGES, LOSSES, DEMANDS OR CONSEQUENTIAL DAMAGES.
2. Vendor agrees to indemnify and hold harmless Dallas Arms Collectors Association, Inc. and its subcontractors, agents, and employees by reason of any claim or liability imposed by law on account of property damage or bodily injuries, including death, resulting therefrom, sustained or alleged to be sustained by any person or persons, whether they be members of the public visiting the show, employees of Dallas Arms Collectors Association, Inc., or other vendors occurring at or in connection with the presentation or presentations of the Dallas Arms Gun and Knife Show, resulting from or arising out of the actions of the Vendor, its agents, employees, or persons performing services for it, or resulting from any equipment, machinery or items displayed by the Vendor.
3. Notwithstanding any remedies available to the Vendor at law, the Vendor expressly releases and waives any and all claims against Dallas Arms Collectors Association, Inc., its subcontractors, agents, officers, directors, shareholders or employees, in consideration of the mutual agreement of the parties and the opportunity of Vendor to exhibit at Dallas Arms Collectors Association, Inc.'s gun and knife shows.
4. Arms or arms related items are defined as guns, gun parts, books about guns, military history, game cooking, gun cleaning supplies, tools designed for gunsmithing, ammunition in sealed containers, reloading supplies and equipment, edged weapons, hunting supplies, military surplus, taxidermy products, and western heritage items.
5. Items excluded from sale include black powder, items displaying vulgarity, obscenity, or death of persons (not including history books), and literature on how to make bombs or illegal guns.
6. It is recommended that all handguns on Vendors' spaces be secured by cord or alarm cable or within glass cases to help resist theft during the show.
7. All ammunition, including vintage and/or collectible, must be contained in boxes or sealed plastic bags. Any ammunition sold shall be put into sealed plastic bags/containers at the time of sale.
8. Loose ammunition in ammo cans/boxes must be covered with plastic and that plastic must be secured to the sides of the can with tape so that the rounds inside cannot be easily removed.
9. The bottom of all hanging signs and banners must be at least 6'8" above the floor and the top of any sign may be no higher than 11 ft. above the floor.
10. No alcoholic beverages or controlled substances may be consumed in Market Hall during show hours.
11. No animals are allowed in Market Hall other than service animals.

FAILURE TO MEET AND COMPLY WITH RULES AND SHOW STANDARDS AS DESCRIBED HEREIN WILL BE GROUNDS FOR REMOVAL FROM THE SHOW WITHOUT REFUND.
